4.) <u>Interview-Based Election Promotion Video by Student Election Commission</u> (in collaboration with the Media Club)

Date: 23 September 2023 Venue: Himalaya Mess and Lawns

Introduction: The Student Election Commission took on the initiative of a dynamic interview-based awareness video as part of its ongoing efforts to promote civic engagement and enhance public understanding of the electoral process. This event aimed to provide a platform for meaningful discourse, perceived insights based on lived experience, and the overall creation of informative yet light-hearted content to promote the upcoming elections.

Event Highlights:

- **Personal Interviews**: The event featured a series of insightful interviews with consenting students providing perspectives on various aspects of the electoral process, mixed with some fun questions in between. The students talked about perceived campaign finance, some grievances due to candidates campaigning, comments based on their own experience as contesting candidates, the bureaucratic procedures associated with the elections, and finally, the role of the Election Commission in ensuring free, fair and smooth elections.
- Interactive Sessions: Following each interview, the audience had the opportunity to engage with the Student Election Commission Head of Secretariat (Events). This allowed attendees to seek clarifications, delve deeper into specific topics, and share their concerns.
- **Permeating Students' Attention**: The end product was a catchy video circulated on social media, where attendees learned informative content about the electoral process mixed with engaging content, to keep the prevailing low attention span in check. The video gave a platform to students to voice their own opinions, which made the video more relatable as the concerns of even those students who were watching were somewhat relayed by others.

Media Coverage:

The event received significant media coverage, and was tediously shared on social media platforms. This extended the reach of the event's electoral awareness messages and content creation efforts to a broader audience. The video currently has close to 2000 views on Instagram.

Interaction of SEC with Students

5.) <u>Candidates' Mental Well-Being Event by Student Election Commission</u> (in collaboration with MITR)

Date: 25 September 2023 Venue: Raman Block 301

Introduction: In an initiative to comfort the candidates, the Student Election Commission organized an event that focused on the mental well-being of election candidates. Recognizing the immense stress and pressure that candidates often experience during electoral campaigns, this event aimed to create awareness about mental health issues and provide resources and support for those in the political arena.

Event Highlights:

• Awareness Sessions: The event commenced with an awareness session by a MITR coordinator that highlighted the importance of mental health in the context of electoral politics. These sessions addressed the specific challenges that candidates face,

including the demands of campaigning, public scrutiny, and the emotional toll of competition.

- **Expert Advice**: MITR associated mental health counselor Ms. Jinna was invited to participate and she shared insights into managing stress, anxiety, and maintaining mental well-being during the rigors of political campaigns. She emphasized the significance of seeking help when needed and reducing the stigma surrounding mental health issues.
- Support Network and Resources: The event brought forth knowledge of available resources to the candidates. Attendees were encouraged to prioritize their mental health throughout the campaign period. A support network was hence established for candidates, as they had access to requisite knowledge and professional attention. This network aimed to provide confidential assistance to those who may be experiencing mental health issues.

Media Engagement:

The Election Commission encouraged responsible media coverage and reporting on candidates' mental well-being. It emphasized the media's role in raising awareness, destigmatizing mental health issues, and promoting a more empathetic discourse around politics.

Promoting mental health in politics is not only a matter of personal well-being but also contributes to a healthier and more transparent democratic process. Despite a lower-than-expected turnout, with only 12-15 candidates joining in, the Student Election Commission considers it pertinent to continue this event.



MiTR briefing session in collaboration with SEC

6.) <u>Monoact Event by Student Election Commission</u> (in collaboration with Drama Club) Date: 27 September 2023 Venue: Mandakini Hostel

Introduction: The Student Election Commission organized a unique and engaging monoact event for the freshers to promote voter awareness and civic responsibility among the citizens. This innovative initiative aimed to use the art of mono-acting to convey important messages about the power of the elected representatives and the significance of voting by every individual.

Event Highlights:

The event featured a series of mono act performances by Khushi Rele, a coordinator of the Drama Club, who showcased her skills in delivering powerful messages through solo acts. Each performance revolved around her role-playing a specific instance where friends discuss their needs and realize that their elective representative has that particular vertical under them, and their needs can be realized if they vote for the representatives who work to realize the needs of everyone.

Themes Explored:

- Voter Education: The event provided valuable insights into the significance of hostel representatives and the spheres they manage, and provided awareness for people in making informed choices in line with their needs.
- **Importance of Voting:** The event emphasized the crucial role of voting in a democracy and the impact of individual choices on the electoral outcome.

Public Participation:

The mono-act event witnessed a diverse audience, including master's and bachelor's students from various departments. The event took place on the ground floor of Mandakini Hostel as there were heavy rains outside. These rains somewhat played to our advantage as people waiting to go out but halted due to the rain, tuned in to see the monoact. In the end, the overall participation of the event was around 50-70 people.



Mono-Acting in Action

Opening of Polling Stations

The polling opened at 10 AM. but the booth setup and infrastructure check were done in advance by the Election Coordinators, collaboratively with the help of hostel managers.

Official Declaration of Results

The official certification of election results and the declaration of winners was announced by mail by the DoSt Office on Saturday 30th September 12:33 pm, the next day after polling.

Discussion

Voter Turnout by Batch

Voter turnout varies significantly across different student batches. These variations highlight the changing levels of engagement and participation over the years.

Fresher's Batch (2023): The fresher's batch of 2023 displayed remarkable participation, with a turnout of 32.75%. Out of the 2,751 eligible students in this batch, 901 actively participated in the election, indicating a positive engagement rate.

Earlier Batches (i.e., 2016 onwards): In contrast, earlier batches such as 2016 showed minimal participation, with only 4 votes. This indicates a considerable disparity in engagement between freshers and seniors, suggesting that tailored efforts may be necessary to motivate earlier batches to vote actively.

Voter Turnout by Program

The voter turnout data, when analyzed by the program, sheds light on the impact of academic programs on student participation.

B.Tech: Among the various programs, "B.Tech" had the highest voter turnout, with 1,655 votes. This substantial participation suggests that engineering students in this program were actively engaged in the electoral process.

PHDMOU: In contrast, "PHDMOU" had the lowest participation, with just one vote. This may indicate a need for targeted efforts to increase engagement among students in less popular programs.

Voter Turnout by Department

Participation variations are evident when analyzing data by the academic department. These disparities provide insights into the engagement levels of students in different fields of study.

Mechanical Engineering: The "Mechanical Engineering" department displayed the highest voter turnout, with 455 votes. This suggests that students in this department were actively involved in the election.

Management Studies: On the other hand, "Management Studies" had a lower voter turnout, with only 34 votes. This difference emphasizes the need to develop strategies to engage students in departments with lower participation rates.

Voter Turnout by Hostel

Voter turnout by hostel highlights engagement disparities within residential communities, influencing participation rates in the election.

MANDAKINI - B: "MANDAKINI - B" emerged with the highest participation, with 374 votes. This indicates that students residing in this particular hostel were highly engaged and active in voting.

DAY SCHOLARS: In contrast, "DAY SCHOLARS" had one of the lowest voter turnouts, with only 21 votes. The data implies that specific efforts may be needed to increase engagement among students in hostels with lower participation.

Voter Turnout by Freshers (2023 Batch Students)

Focusing on the freshers' batch of 2023, this segment of the analysis delves into their participation in detail.

Voter Turnout: The data reveals that the fresher's batch of 2023 exhibited a commendable voter turnout of 32.75%. Out of the 2,751 eligible freshers, 901 students actively participated in the election, indicating a positive level of engagement.

The comprehensive analysis of voter turnout by batch, program, department, hostel, and freshers (2023 batch students) provides valuable insights into the participation patterns among students. These insights can be used to develop targeted engagement strategies to increase voter turnout, foster a more engaged and informed student body, and ensure that every eligible student has the opportunity to participate in future elections or events.

Complaints & Grievance Redressal

SEC throughout the elections has been dealing with complaints that are often raised against the candidates who are not abiding by the Election Manual or the Model Code of Conduct.

Following is the small gist of the complaints that SECC received during the Freshers' & ISS Elections 2023.

- Violation of the Campaigning Guidelines mentioned in the Model Code of Conduct was the most common ground on which multiple complaints were filed with the SEC. In total 20 such complaints were filed with SEC where Incidents like candidates campaigning before or after the prescribed campaigning period (22nd September, 5:00 PM to 28th September, 10:00 PM) either through online mode (social media campaigning through Instagram or WhatsApp) or offline mode (door-to-door campaigning or sharing manifestos) were communicated to SECC.
- There were 5 complaints that were technical in nature and questioned the technical glitches that candidates were facing while filing the nomination form or getting their candidature proposed or seconded by their friends.
- There were 5 complaints from GSB that questioned the decisions, legitimacy, and functioning of SEC on the grounds that SEC should have conducted elections on some other date and shouldn't have kept the polling day during the beginning of the long weekend. The SEC clarified that due to the urgent need of the ISS and after a due deliberation with all the stakeholders including Executive Council 2023-24, Election Officers, CCW Chairman, DoST Sir, SECC & SLC Faculty Advisor, SEC had decided to conduct polling on 29th September 2023.
- Moreover, there was one unique complaint that was launched against SEC mentioning about the mismanagement of Elections to which SEC countered all the complainant's arguments with legitimate proof and reasons, keeping in loop DoST Sir, Election Officers, and SECC & SLC Faculty Advisor.
- After due deliberation on the veracity of the complaint and checking the legitimacy of the evidence, SECC used to 'acknowledge' the complaint within 24 hours. After a thorough investigation of the complaint, SECC imposed sanctions on the candidates who violated the Model Code of Conduct within 48 hours of acknowledging the complaint's complaint.
- The sanctions that were imposed by the SEC ranged from giving warnings to asking candidates to delete their Instagram posts or messages that they had circulated without following the social media campaigning guidelines. In this election, none of the candidates was asked to send a public apology and neither was any candidate's nomination canceled. Most of the sanctions imposed by SEC were restorative in nature as the complainant was always BCC'd in the mail which mentioned the sanction that was directly imposed over the candidate who had violated the election guidelines.
- During the Freshers' & ISS Elections 2023, SEC took suo moto cognizance against three Executive Council members who violated the Election Manual and Model Code of Conduct by approving two of the ISS Candidates' mail to GSB without taking due permission from SEC. Secondly, when one of the EC members approved a complaint by a GSB Member to the smail when the polling was going on which is an attempt to influence the voters' decision without any legitimate proof. SEC did not recognize his complaint on the grounds of intentionally influencing the voters at the time of polling with

false allegations and hence did not take any action against whom the complaint was launched as he did not follow the prescribed procedure of filing a complaint to SEC.

• DoST Sir, Elections Officers, and SLC & SECC Faculty Advisor have taken the required action against the three Executive Council members who violated the Election Manual and Model Code of Conduct in their official capacity.

Recommendations

Feedback from GSB

To improve the voting experience and the fairness of elections, several key recommendations have emerged from student feedback. Firstly, the introduction of online voting is suggested to accommodate students who are absent during long weekends and boost overall participation. Secondly, scheduling elections on weekdays rather than during holidays and long weekends is proposed to make voting more convenient for the majority of students. Thirdly, efforts in communication and outreach are recommended to raise awareness about voting's significance and the candidates, ultimately increasing participation and informed decision-making.

Additionally, addressing technical issues within the voting portal to ensure its robustness and user-friendliness is crucial to prevent disruptions and confusion. Encouraging fair campaigning and discouraging candidates from inundating messaging apps with campaign material is advised to maintain a level playing field. Enhancing the security of the online voting system to eliminate proxy voting concerns is essential for the integrity of the process. Promoting general awareness among residents about their civic responsibilities and engaging students in the electoral process will make them more interested in learning about candidates and attending campaign events.

Furthermore, the implementation of additional restrictions on polling day is suggested to prevent irregularities and manipulation by agents of contestants. Ensuring that the Student Election Commission (SEC) is responsive to student concerns and addresses issues in a prompt and transparent manner is crucial for maintaining trust in the electoral process. Taking into account the feedback regarding low voter turnout during long weekends, rescheduling elections to maximize representation and participation is recommended. Additionally, enforcing a minimum threshold of candidate attendance (e.g., 50%) is advised to ensure a competitive and representative election.


